

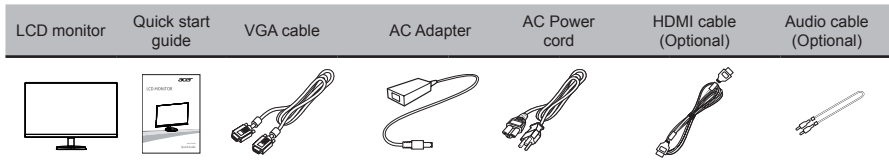
Acer LCD Monitor Quick Start Guide (QSG)

Important safety instructions

Please read the following instructions carefully.

- To clean the LCD monitor screen: Be sure that your monitor is electrically rated to operate with the AC power available in your location.
 - Turn off the LCD monitor and unplug the power cord.
 - Spray a non-solvent cleaning solution onto a rag and clean the screen gently.
 - NEVER SPRAY OR POUR ANY LIQUID DIRECTLY ONTO THE SCREEN OR CASE.**
 - PLEASE DO NOT USE ANY AMMONIA OR ALCOHOL-BASED CLEANERS ON THE LCD DISPLAY SCREEN OR CASE.**
 - Acer will not be liable for damage resulting from use of any ammonia or alcohol-based cleaners.
- Do not place the LCD monitor near a window. Exposing the monitor to rain, moisture or sunlight can severely damage it.
- Do not apply pressure to the LCD screen. Excessive pressure may cause permanent damage to the display.
- Do not remove the cover or attempt to service this unit yourself. An authorized technician should perform servicing of any nature.
- Store the LCD monitor in a room with a temperature of -20° to 60° C (-4° to 140° F). Storing the LCD monitor outside this range may result in permanent damage.
- Immediately unplug your monitor and call an authorized technician if any of the following circumstances occur:
 - Monitor-to-PC signal cable is frayed or damaged.
 - Liquid spills onto the LCD monitor or the monitor is exposed to rain.
 - The LCD monitor or case is damaged.

Adjusting the monitor base

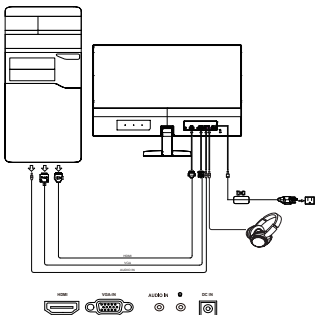
- Carefully remove the monitor from its packaging.
- Pull the monitor base out fully so that the monitor can be placed on a stable surface in the upright position.
- Secure the monitor base by turning the white screws (at the bottom of the base) using the integrated tab or a suitable coin.

Connecting your monitor to a computer







- Turn off your computer and unplug your computer's power cord.
- 2-1 Connect Video Cable
 - Make sure both the monitor and computer are powered-OFF.
 - Connect the VGA video cable to the computer.
- 2-2 Connect HDMI Cable (Only HDMI-input model)
 - Make sure both the monitor and computer are powered-OFF.
 - Connect the HDMI cable to the computer.
- Connect the Audio Cable. (Only Audio-Input Model) (Optional)
- Insert the monitor power cable into the power port at the back of the monitor.
- Plug the power cords of your computer and your monitor into a nearby electrical outlet.

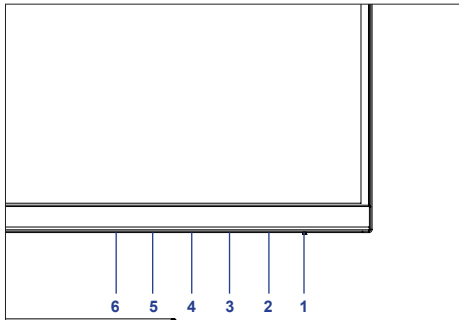


Note: Audio output is only for audio output model. Please check user manual for more instruction.



Panel controls

No.	Icon	Item	Description
1		Power button/ indicator	Turns the monitor on/off. Blue indicates power on. Blinking blue indicates standby/power saving mode.
2		OSD function	a. Press to view Main page. Press again to enter next function in the Function Menu. b. When the Function Menu is active, press this key selected or move to the next function.
3		Input	a. Press to view Main page. Press again to enter Input select function. b. When the Function Menu is active, press this button selected or move to the previous function.
4		Volume	a. Press to view Main page. Press again to enter Volume adjustment function. b. When the Function Menu is active, this button will enter a selection in the OSD.
5		Brightness	a. Press to view Main page. Press again to enter brightness adjustment function. b. When the Function Menu is active. Press to return previous Menu or exit current Menu.
6		Mode	a. When the Main page is active. Press to trigger the Game mode control b. When the Function Menu is active, press to exit current Menu.



FreeSync:

It can allow a FreeSync supported graphics source to dynamically adjust display refresh rate based on typical content frame rates for power efficient, virtually stutter free and low-latency display update.
