
Acer LCD Monitor Quick Start Guide (QSG)

Important safety instructions

Please read the following instructions carefully.

- 1. To clean the LCD monitor screen:
 - Turn off the LCD monitor and unplug the power cord.
 - Spray a non-solvent cleaning solution onto a rag and clean the screen gently.
- 2. Do not place the LCD monitor near a window. Exposing the monitor to rain, moisture or sunlight can severely damage it.
- 3. Do not apply pressure to the LCD screen. Excessive pressure may cause permanent damage to the display.
- 4. Do not remove the cover or attempt to service this unit yourself. An authorized technician should perform servicing of any nature.
- 5. Store the LCD monitor in a room with a temperature of -20° to 60°C (-4° to140°F). Storing the LCD monitor outside this range may result in permanent damage.
- 6. Immediately unplug your monitor and call an authorized technician if any of the following circumstances occur:
 - Monitor-to-PC signal cable is frayed or damaged.
 - Liquid spills onto the LCD monitor or the monitor is exposed to rain.
 - The LCD monitor or case is damaged.





Attaching the monitor to the stand

- 1. Remove the monitor bracket and base from the packaging and place it on a stable and level workspace.
- 2. Remove the monitor from the packaging, by aligning the front-end of the bracket with the corresponding slot on the back of the display, push the bracket into the slot until you hear a click sound.
- Push the stand against the bracket and turn the screw clockwise to fasten it. By doing so, the bracket shall be installed on the monitor.

Connecting your monitor to a computer

- 1. Turn off your computer and unplug your computer's power cord.
- Connect the signal cable to the DP (optional) and/or HDMI (optional) input socket of the monitor, and the DP (optional) and/or HDMI (optional) output socket of the graphics card on the computer. Then tighten the thumbscrews on the signal cable connector.
- 3. Insert the monitor power cable into the power port at the back of the monitor.
- 4. Plug the power cords of your computer and your monitor into a nearby electrical outlet.
